WHAT YOUR DOLLARS CAN DO*

- \$2 per week** Provides 42 young children with an age-appropriate book of their own; access to books helps children develop their reading skills as well as promotes imagination and creativity.
- \$5 per week** Assists food banks in purchasing more than 1,500 meals for individuals experiencing financial difficulties.
- \$10 per week** Provides a victim of domestic violence with 12 nights of safety and shelter.
- \$20 per week** Provides 70 individuals experiencing homelessness with the proper identification to apply for benefits, employment and education.
- \$30 per week** Provides 52 individuals who are participating in education and employment courses with monthly bus passes.
- \$50 per week** Allows more than 20 families to attend financial education courses, helping them to become more financially stable and move out of poverty.
- \$100 per week** Provides 48 children with early learning developmental assessments to prepare them to enter school ready to succeed.
- \$200 per week** Provides 65 young adults with educational courses that prepare them to enter the workforce.
